

Personal Import of WockhardtUK Ltd bovine insulins into Canada

This guide has been written to help you if you have not been able to find a suitable replacement for Iletin® 1 in Canada and wish to obtain beef insulin from WockhardtUK Ltd.

Although Wockhardt's bovine insulins have been approved and used in the United Kingdom and other countries for the last 25 years, they are not yet approved for use in Canada. Therefore, WockhardtUK Ltd cannot supply insulin to you as a resident of Canada until you have received permission from the relevant Canadian authorities to bring the insulin into Canada.

This is what to do:

1. A letter of authorisation must be obtained by your doctor, from the following authority:

2. Health Canada will send a copy of the authorisation direct to your doctor and a copy to WockhardtUK Ltd.
3. When your doctor receives this he or she should complete an order form (copy attached) and return it to WockhardtUK Ltd.
4. A 'Compassionate Use/ Named Patient Supply: Drug Safety (Pharmacovigilance) Agreement for Hypurin Insulin'
completed by the licensed practitioner responsible for the treatment of your diabetes.

Note: Communication regarding technical or medical aspects of Hypurin insulin or its use.

The Company must ensure that the patient communicates directly with and obtains all advice on his or her diabetes treatment from the physician responsible for treatment of his or her diabetes.

- The Company can not communicate directly with the patient regarding technical or medical aspects of Hypurin insulin or its use.
- The patient must direct all enquiries of this nature to the physician responsible for treatment of his/her diabetes.

- Contact with the Company on matters of this nature must be made by the physician responsible for treatment of the patient's diabetes.
- Communication received by the Company directly from the patient, will be forwarded within two working days of receipt, to the physician responsible for treatment of the patient's diabetes.
